

Making Mealtimes July 2020 Photo Contest Official Rules

- NO PURCHASE IS NECESSARY TO ENTER OR RECEIVE PRIZE. A purchase is not required and will not improve your chances to win. The Prairie Fresh Making Mealtimes Photo Contest ("Contest") is open to legal residents of the United States, who are at least 18 years old. Employees of Seaboard Corporation, Seaboard Foods LLC, Seaboard Foods Services, Inc.
